

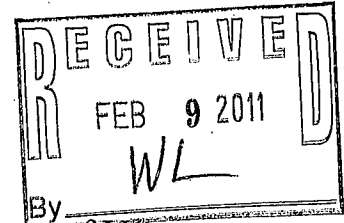

On June 1, 2010, pursuant to the authority provided in the State of Vermont Municipal Pollution Control Priority System, the Department of Environmental Conservation adopted The FY 2011 Pollution Control Projects Priority List. In accord with Sections 410 and 420 of the Municipal Pollution Control Priority System the Department has reviewed the status of projects on that List and the requests of municipalities for funding of projects not included on the Construction Projects portion of the List.
