**PERMIT AND LICENSE INFORMATION**

**SMALL BUSINESS FACT SHEET FOR LICENSED CHILD CARE**

**The Law:** Vermont Law (33VSA Section 3502) requires that persons who wish to provide child care to children from more than two families must first obtain a license from the Department for Children and Families (DCF).

**DEPARTMENT OF ENVIRONMENTAL CONSERVATION**

A proposed licensed childcare facility may have to obtain a **Wastewater System and Potable Water Supply Permit** ([Sheet # 1](#) \*) from the Department of Environmental Conservation (DEC). The DEC permit will address the condition of the water and septic systems and determine whether the addition of a childcare program would burden these systems, thereby potentially creating a health hazard. In order to obtain the permit, the DEC Regional Engineer will need information about the existing water and sewage systems. If municipal water and sewer serve the structure, a letter from the town will be needed along with a completed application. If the structure is served by on-site water and/or septic systems, a design by a licensed designer ([Sheet #11](#)) or a certification on the construction of the current systems may be needed. If there is on-site water, tests for bacteria and certain chemicals will be required. A minimum fee of \$210 is required for the **Wastewater System and Potable Water Supply Permit** and may take 45 days or longer to process. In certain instances, a permit for your project may not be feasible. If your facility serves **more than 24 people** a day, and you are not connected to a municipal water system, you may need a **Water Supply Permit to Operate** ([Sheet #21](#)). The Fire Safety Division of the Department of Public Safety helps child care providers assure that the children and other day care users are safe from fire, electrocution, malfunctioning heating plants and other hazards. The department needs to receive information about the building and the proposed use. This information includes:

- the maximum number of children to be served at any one time
- the age span of the children
- how many caregivers will be on duty at any given time
- the type of material used in the construction of the building (wood frame, steel, concrete, etc)
- the number of stories in the building, and which levels are proposed for child care
- the type of heating system
- the location of all exits

The Fire Safety Division uses nationally recognized codes to evaluate the safety of the building. A combination of smoke detectors and fire extinguishers will be required; fire alarms and/or sprinkler systems may be required. The Division usually does not require submission of plans for an existing building, unless renovations or an addition are being considered. If a new building is being constructed,

plans must be submitted to the regional office for review. An architect or engineer must prepare the plan for a new building. If plans are not required, a site visit will be necessary, and a \$25 fee is required for the inspection service.

Lead and Asbestos Program (Sheets # 54 & #55 \*)

**Lead:** If the building was constructed prior to 1978, the owner of the building must meet the requirements of Act 165, regarding lead hazard control measures that may need to be taken.

**Asbestos:** If the proposed site is an existing building, an asbestos assessment shall be performed by a person certified by the Vermont Department of Health to determine:

- if asbestos containing material is present, and
- if asbestos containing material is present, to ascertain the condition of such material.

The Asbestos and Lead Regulatory Program of the Department of Health may be contacted to conduct asbestos assessments at reduced costs by calling **1-800-439-8550 (in Vermont)**.
