## Fees

Effective July 1, 2004

### Discharge Permits, Pretreatment Discharge Permits, Indirect Discharge Permits and Underground Injection Control Permits

Issued Under 10 VSA Chapter 47

An applicant or permittee regulated under Chapter 47 is subject to three different fees:

**Administrative Processing Fees** apply to applications for new/original permits, permit amendments, transfer of permit and renewal permits including individual and general permits. The fee is \$100.00 per application. *This fee did not increase in 2004.*

**Application Review Fees** are payable for review of

- original applications
- applications for amendment for increased flows
- applications for a change in a treatment process, and
- applications for amendment for modification or replacement of system

**Note:** The application review fee does not apply to applications for renewal, transfer or minor amendment of an individual permit. A list of minor amendments follows this table.

The application review fee rate depends on the type of permit or discharge.

Municipal, industrial, noncontact cooling water and thermal discharges	\$0.0023 per gallon design flow; minimum \$50.00 per outfall; maximum \$30,000.00 per application

Pretreatment discharges	\$0.12 per gallon design flow; minimum \$50.00 per outfall
Stormwater discharges - Individual permit or approval under general permit for stormwater runoff from industrial facilities with specified SIC codes.	\$150.00 per facility
Indirect discharge of sewage	\$1,755.00 plus \$0.08 per gallon of design capacity above 6,500 gallons per day
Amendment of individual sewage permit for modification or replacement of system	\$0.08 per gallon of design capacity involved
Indirect discharge of non-sewage  Non-sewage discharge authorized by UIC permit	\$0.06 per gallon of design capacity; minimum \$235.00 per application

**Wastewater Management Division – Chapter 47 Fees  
List of Minor Permit Amendments for Chapter 47 Permits**

Only the administrative processing fee is required for permittee requests for minor permit amendments. Minor permit amendments require minimal or no technical staff review and include the following permit actions:

- transfer of ownership
- permittee name change
- reduction in monitoring frequency
- delete parameters from the table of monitored parameters
- change in sample type or duration
- change in units of measurement
- change in sampling location
- change in requirement for certified operator or in the operator grade level required
- change inspection date or inspection report submittal date
- modify implementation schedule dates with regard to periodic status report submittals

**Annual Operating Fees** will be billed to all persons who hold operating permits. The rate charged depends on the type of permit or discharge.

Municipal discharges	\$0.0027 per gallon of <u>actual</u> flows; \$100.00 minimum; maximum \$11,000.00
Pretreatment discharges	\$0.0315 per gallon design capacity; \$100.00 minimum; maximum \$27,500.00
Stormwater discharges - Individual permit or approval under general permit for stormwater runoff from industrial facilities with specified SIC codes.	\$55.00 per facility
Indirect discharge of sewage – individual permit	\$385.00 plus \$0.0317 per gallon of design capacity above 6,500 gallons per day; \$350.00 minimum; maximum \$27,500.00
Indirect discharge of sewage – approval under general permit	\$220.00
Indirect discharge of non-sewage – individual permit  Non-sewage discharge authorized by UIC permit	\$0.013 per gallon of design capacity; \$100.00 minimum; maximum \$5,500.00
Indirect discharge of non-sewage – approval under general permit	\$220.00
