Nearly \$500,000 is available through three separate categories of grants. Each grant category has different award amounts, eligibility criteria, and cost-share requirements.

### COMMUNITIES CARING FOR CANOPY

Grants up to \$20,000 available to support a wide range of activities that move local urban and community forestry programs forward statewide.



### GROWING URBAN FORESTS IN THE FACE OF EMERALD ASH BORER

Grants up to \$50,000 available to support removal of ash trees and replanting of other species within the public right-of-way and parks in urban areas and along corridors that lead to downtowns and village centers.



### URBAN & COMMUNITY FORESTRY GRANTS

Grants up to \$50,000 available to support work in specific communities to increase and maintain a healthy urban canopy and access to nature.
