EAB, an invasive beetle that feeds on and kills all species of ash trees, was confirmed in Vermont in February 2018. Already in 31 other states and three Canadian provinces, the economic impact of EAB has been greater than any other invasive forest pest in North America. Municipalities will bear the responsibility and costs of removing public trees that pose a safety risk, treating public ash trees of cultural or historic value, and replanting other species that strengthen the ecological, economic and aesthetic benefits provided by urban and community forests. This session will focus on resources and actions needed to mitigate the impact of EAB when it reaches your community.
